I. PREAMBLE / INTRODUCTION : -

II. FIRMS ELIGIBLE TO TENDER: -

1. INTERIOR & INTERIOR CIVIL WORKS: -

- a. The bidder should have a minimum of five years of experience in execution of Interior Civil works / interior works for government institutions.
- b. The bidder shall have sufficient technical personnel on rolls capable of executing works as per prescribed specifications.
- c. The bidder shall have annual turnover of not less than Rs.3.00 crores for the past three financial years and furnish audited annual accounts.

- b) The bidder shall have a full fledged workshop with sufficient technical personnel capable of executing works as per prescribed specifications and also to attend after sales service.
- c) The bidder shall have annual turnover of not less than Rs.1.00 crore for the past 3 financial years.
- d) The bidder / firm shall have GST, PAN,SSI / Factory / Workshop Registration certificate.
- e) The bidder should submit
- Audited accounts for past 3 Financial years.
- Experience of at least 5 years in supplying furnishings to Government Departments.

5. STATIONERY & ELECTION MATERIAL ETC..

The bidder shall submit pre-qualification bid along with relevant documents indicated in application in a separate sealed cover duly superscribing "pre-qualification Bid for (Name of the work) with name and address of the bidder. The pre-qualification Bid should be submitted along with covering letter and EMD.
- c. IV. GENERAL TERMS AND CONDITIONS: -

- 1. Earnest Money deposit of Rs.2,00,000/- based on the work will be retained and converted to security deposit. The security deposit for Sl.No.1 and 2 is Rs.5.00 Lakhs and Sl.No. 3 and 4 Rs.2.00 Lakhs and S.No.5 is 1.00 lakh for each type of work. The balance amount is to be deposited the successful bidders before entering into agreement. This deposit will not carry any interest. The entire amount will be converted into interest free security deposit.
- 2. The agreement period will be up to 31-03-2026 from the date of signing the agreement. No Escalation charges will be paid for supply of items during execution of works in the agreement period.
- 3. The empanelled bidders will be directed to submit open competitive bids for every order received from government departments. The empanelled bidders will be assessed on the lowest quoted rates as well as the competitive service charges offered to TGHDC Ltd over and above 7% minimum service charges on the total order.
- 4. Negotiations will be held with "L1" as per the decision of the Technical Committee. The aim is to reach agreement on all the points and sign a contract for relevant Government order.
- 5. In case of furniture and furnishings must be covered with warranty period for one year from the date of supply. Any defective noticed due to manufacture / workmanship etc., the Repairs / Replacements / Servicing shall be attended free of cost within the warranty period.
- 6. In any case, the indenting Department insists any security deposit on execution works, the Contractors / Supplier should deposit required amount on behalf of Corporation / GHE. Further the Corporation / GHE will be retained the amount from the bills of Contractors / Suppliers to the extent of amount recovered / retained by the indenting Department towards security deposit IT and GST from the R.A bills of Corporation / GHE. The entire security deposit will be released to the Contractor on receipt of the same from respective Department after completion of defective period if any. Regarding, IT & GST amounts will be released on receipt of certificates from respective Department.
