3. The Tenderer should have filed I.T. Returns for the last (3) Financial years. (Copies of IT Returns along with acknowledgements only to be enclosed)
4. The Tenderer shall deposit EMD of Rs.2.00 lakhs in the manner as prescribed along with the Tender.

- a) Sealed Tenders are invited from the reputed Decorators/Event Managing firms/Contractors registered with any Government Authority of the Country for construction, electrification and other related allied works including its maintenance at the proposed **NATIONAL HANDLOOM DAY/ EXHIBITION –2024 from 07.08.2024 to 16.08.2024** to be held at PEOPLES PLAZA, Hyderabad, Telangana State for (10) days.
- b) The duration of the Exhibition will be (10) days. However, in case, if it is felt necessary the duration of Exhibition may be extended further for one to two days, and no extra payment shall be made to the Contractor. On completion of the Exhibition, the Contractor shall have to take away all the materials within (1) day and shall have to vacate the site. He shall have to pay Rs. 15,000/- per day for the number of days he occupies the site beyond the period allowed for vacating i.e., (1) day after completion of the Exhibition.
- c) The Exhibition Ground will be formally made available to the Contractor by the Exhibition Authority from **04.08.2024**. The Construction Work must be started immediately at the site on the same day and be completed and handed over to the Exhibition Authorities **on 05.08.2024 by 4.00 P.M. without fail**. The progress of the work will be checked and supervised by the Officers duly nominated by the Exhibition Authority to ensure that the work is done as per the specifications and time schedule. Tenderers are advised to inspect the site for physical condition before filing the Tender.

- d) In case any portion of work is not completed as per specifications laid down and failed to hand over to the Exhibition Authorities on the due date, penalty up to 5% on the total value of work allotted / awarded will be imposed per day by the Exhibition Authority.
- e) The volume and number of works may vary at the discretion of the Exhibition Authority, up to 30% of the contracted work and the final payment to the Contractor shall be regulated on the basis of actual work executed and on the rate(s) initially approved. For extra fittings contractor will have to quote rates separately. For all such extra fittings, the Exhibition Authority reserves the right to pay the lowest of the rates quoted by the competing Contractor.
- f) The Contractor will be responsible for up-keeping and maintenance of the entire work done by him till the closing of the Exhibition, for which, no extra payment shall be made. He shall therefore have to ensure adequate number of Sweepers / Cleaners to the satisfaction of the Exhibition Authority. Breakages and damages in any work shall immediately be rectified and no extra payment will be made for any damage, breakage or loss on account of any reason or natural calamities. Draft Layout Plans, elevation of Front Gate etc., of the construction of Stalls, Theme Pavilions etc., shall have to be provided by the Tenderers along with the Tender Schedules. The successful bidder has to give or adopt the plans as suggested by the Exhibition Authorities and take approval of the Competent Authority before commencing construction. The Director of Handlooms and Textiles and A.E.Ps., Government of Telangana reserves the right to reject any of or all the Tenders without assigning any reason or to accept any portion of the Tender and Award the remaining work to any other Contractor.
- g) No part of the Contract shall be sublet without the prior written permission of the Director of Handlooms and Textiles and A.E.Ps./ Exhibition Authority.
- h) It shall be the responsibility of the successful Tenderer/Contractor to obtain requisite permissions for the supplies of Water, Electricity, Sewerage and other essential connections at the Exhibition ground for the duration of the Exhibition i.e., from the date the ground is handed over to the Contractor for construction till the date the ground is handed over back to the Local Authority from whom it has been taken on rent. It shall also be the responsibility of the Contractor to liaison with the concerned Authorities and arrange all the Civil, Electrical connections and other amenities that may be required for running the Exhibition. The Exhibition Authority shall also address letters to the concerned Authorities. The Exhibition Authority shall pay the Security Deposits, Installation Charges and Consumption Charges for all Civil and Electrical connections for the duration of the Exhibition.
- i) With regard to Electrical Fittings etc., the Contractor shall have to engage a qualified licensed Electrical Contractor entitled to erect, handle and maintain High Tension supply line and its up-keep and maintenance of the facility without any scope for short-circuits/fire accidents during the Exhibition period.
- j) The Contractor shall not use any material other than those specified in the Tender without the prior permission of the Director of Handlooms and Textiles and A.E.Ps., T.G. Hyderabad / Exhibition Authority.
- k) Part payment may be made to the Contractor according to the progress of the work under mutually agreeable terms between the Contractor and the Exhibition Authority. Final payment will be made only after the completion of the Exhibition and after handing over of the ground to the Exhibition Authorities.



- l) The Tenderer should fill the rates tendered in figures as well as in words. The Tender Form may be filled in English and all the entries shall be made by hand and written in ink. Over writing in rates is not permissible. The Tenderer with his initials should attest all corrections if any in Tender form. Each page of the tender form and other related papers submitted therewith should be signed by the Tenderer.
- m) Tenderers are required to deposit Earnest Money Deposit (EMD) of Rs.2.00 lakhs. The amount of Earnest Money will be accepted only in the form of Demand Draft drawn in favour of "**The Director of Handlooms and Textiles and A.E.Ps., T.G, Hyderabad**". Only those Tenderers who have necessary expertise in the execution of the job within the stipulated time should submit the Tenders. The Tender without earnest money deposit will not be accepted.
- n) The Director of Handlooms and Textiles and A.E.Ps., T.G., Hyderabad/ Exhibition Authority is not compulsory bound to accept the Lowest Tender and reserves the right to reject any or all Tenders without assigning any reason. Conditional Tender in any form whatsoever will not be qualified / considered and will be liable for outright rejection.
- o) The successful Tenderer shall immediately and not later than the next day of intimation of acceptance of Tender, sign an Agreement on the Non - Judicial Stamp Paper of the value of Rs.100/-. Failure to do so shall give the Director of Handlooms and Textiles, A.E.P.s, T.G., Hyderabad/ Exhibition Authority, the right to revoke the acceptance of the Tender without further notice to the Tenderer, and to forfeit the Earnest Money Deposit (E.M.D.) and to award the work to any other Contractor.
- p) The Earnest Money of the successful Tenderer will be retained as Security Deposit till successful completion of the contract and shall be returned only after Exhibition is over and after payment of final bill.
- q) The word Director/ Exhibition Authority will read and include Director of Handlooms and Textiles & A.E.Ps., T.G., Hyderabad.
- r) The successful Bidder shall be required to furnish performance guarantee (Bank guarantee) equal to the value of the bid before taking possession of the site.
- s) Financial bid shall be kept in a separate cover and sealed. The Said Cover along with Technical Bid and other enclosures shall be kept in a big cloth cover and sealed and shall be delivered to the Competent Authority.

**MODALITIES FOR EXECUTION OF VARIOUS WORKS**

**1. Construction of Total Pavilion:**

- Total super structure with closed roof and gaps between the rows of the National Handloom DAY/EXHIBITION -2024 at PEOPLES PLAZA, Hyderabad, Telangana State should be constructed as **Indoor** with German structure.
- Top of the structure shall be covered with Rain Proof German structure.
- Stalls numbering Approx. 110-120Nos. (10'x10') shall be constructed with the height of **12** feet in the Indoor of the total Super-structure with closed roof with octonorm and false ceiling.
- Wooden Platform should be provided inside the stall structure with Synthetic Carpet.
- Name of the Stall Holders should be pasted with Vinyl lettering on the front side pane of each stall.
- Adequate number of Fire Extinguishers as approved by Fire Authority shall have to be installed, one each for common and another suitable for Electrical short-circuit. They should be installed at places as directed by the Fire Authority.
- Iron Steel Barricading Fencing grill shall be provided around the Super-structure.
- Electrical Lights and Fan Fittings are to be provided with necessary wiring on the main line separately for (a) Fan, (b) Light, (c) Night Lamp, distribution and point wiring including Switch, Main Switch etc., using I.S.I standard wire and Light Fittings complete as may be approved by the Local Electrical Authority. All Fittings should be properly focused to enable proper lighting at the Sales Counter and General Lighting at the Pavilion.
- Additional items if provided over and above the prescribed number on, the demand of the Participants, the Contractor shall have to supply the same at the rates quoted in the Tender for the respective items. No extra charge shall be collected from the participants.
- All Electrical Works including Fittings and Fixtures and wiring must be done through a Licensed Electrical Contractor borne in the current approved list of T.G. Transco W.D. (Electrical/CPWD etc.,) who will submit and obtain necessary approvals and submit TEST FORM to Executive Engineer, TGSPDCL, Hyderabad (Electrical) for power connection.

## **2. Construction of Theme Pavilion:**

- Theme Pavilion shall be constructed inside the Super-structure with separate Entrance Gate

## **3. Generator:**

Two **(2)** Sound Proof Stand-by Generators of 125 KVA should be provided round the clock at the EXHIBITION site to provide adequate Power Supply to each Stall in the event of Power/Electrical failure so as to enable smooth running of the EXHIBITION.

## **4. Lighting arrangements inside and outside the Pavilion:**

- a) CFL Lights with 40W Capacity are to be provided in the Stalls.
- b) Florescent Day Lights to be provided in the Inner Area of the Super-structure.
- c) Florescent Flood Lights to be provided in the Inner Area of the Super-structure and Outside the Super-structure.
- d) Decorative Lights to be provided for Beautification of the EXHIBITION Area.

## **5. Other arrangements inside the Pavilion:**

- a) Ceiling Fans of Branded Company like Usha, Khaitan etc., shall only be provided in the Inner Area of the Super-structure.
- b) Pedestal Fans of Branded Companies only to be provided in the Inner Area of the Super-structure as per the instructions of the EXHIBITION Authorities.
- c) Iron Racks with good quality and condition are to be provided in the Stalls.
- d) Fiber Chairs in good condition are to be provided in the Stalls.
- e) Steel Tables without rust and with good quality are to be provided with cloth cover.

## **6. PUBLIC ANNOUNCEMENT SYSTEM:**

- One Public Address System should be provided with Light Music and Mike in office.
- One Public Address System should be provided on the stage for Cultural Programmes and public meeting.

## **7. FIRE BRIGADE OFFICE:**

- A Fire Brigade office for Fire Tender is to be provided with Zinc sheets.
- Contractor should provide Fire Extinguishers for fixing in Super structure and Public meeting area.

## **8. Canteen:**

A Canteen shall be constructed with Zinc Sheets also side walls.

## **9. Construction of Stage/Platform:**

- For conducting Public Meeting to be attended by the Chief Guest and Other Dignitaries, a separate platform duly decorated with sufficient Lighting and Power connections is required to be constructed.
- LED Screen shall be arranged on the stage back drop.

**10. BATH ROOM/WCs:**

Contractor has to provide Mobile Bathrooms and Toilets for the use of the participants and visitors on round the clock basis. Sufficient Water supply has to be ensured by the Contractor and arrangements for handling spoiled/dirty water are to be made on large scale to handle the expected volume of rush.

**11. Main Entrance Gates:**

Box Type Entrance Gates should be constructed as per the design given by the EXHIBITION Authority.

**12. Maintenance of entire Event Area of EXHIBITION:**

The Contractor should appoint required Sweepers/Cleaners to clean the entire area of the EXHIBITION (Inside and outside the EXHIBITION) at his cost.

**13. Security Arrangement :**

The contractor shall provide (15 Nos.) security personals in two shifts consisting (09) persons during day time and (06) persons during night time.

**14. CC TV arrangements :**

Contractor should provide CCTV camera & Metal detectors and Man power along with CCTV footage in the surroundings of Superstructure at Venue.
